Constable Jefferson Hobbs is a newly-elected constable, serving in DeWitt County, Pct.2. Constable Hobbs won his primary election in 2020 to fill an unexpired term and took office in January 2021. Like many offices in the last two years, Constable Hobbs has adopted Zoom technology to his office's advantage, especially with truancy cases. "We've been able to deal with students that have truancy, appear in court without losing much instructional time if they are at school on court days." Even though Constable Hobbs is new to the role, he's constituent feedback listening to and expanding a Law Enforcement presence in previously underserved areas of his precinct like Yorktown. When asked about advice for new Constables or those considering getting into the role, Constable Hobbs offered this advice. " Mentally prepare yourself for the political side of things." Constable Hobbs is doing great things in DeWitt County and is excited about what's to come in Pct.2!

Judge Blanca McBride came to the office of the Justice of the Peace 41/2 years ago. She has taken the bull by the horns and really tackled some issues. Since her time in office she initiated the change for a new debt collection agency that has made her office as well as others not only more efficient, but also has created more revenue for the county. She has been a huge proponent for technological advances that not only help give access to the public, but also help her and her staff operate better.

Due to budgetary issues, Judge McBride also doubles as a civil clerk on top of her judicial role.

One interesting fact about Judge McBride was in August of 2020, she was able to become a kidney donor for her sister in law. "For me, that is a very proud moment, where you can truly feel like you helped save a life." Her sister in law is now thriving and doing great.

#### Why do you think living by faith important?
