
If you had to scrap all social media except one, which would you keep?




Do you prefer a margarita frozen or on the rocks?




What's one thing you wish you had more of?




Greatest Country & Western singer?

Chaplain's Corner

If you were asked a question of what is right and wrong?

One might respond, "it depends." Ernest Hemingway said this, "what is moral is what you feel good after and what is wrong is what you feel bad after." So, he is saying that morality is a matter of personal preference, not divine mandate. This can be found in the period of the Judges where it says, "in those

days there was no king in Israel; every man did that which was right in his own eyes." Judges 21:25

A Seminary professor once said, "Right is right because it expresses the unchanging nature of God and his will for his creation."

I believe that God is the only true basis for determining right and wrong. I trust that you agree with me.

"Right" as determined by God

consist of moral absolutes. I am saying that what is right is always right; what is wrong is always wrong.

The opposite of this approach is called" Moral Relativism.
This is the behavior that what is right and wrong depends on the time, place, person, and situation involved.

As we all serve in our capacities as Judges, Constables, Deputy Constables or Clerks we should strive to always do what is "right'!

DEAR BRONSON—GREAT ADVICE FOR YOUR PRECINCT



QUESTION: We had a small claims case in which a Plaintiff lent her best friend money. They have text messages going back and forth where the defendant agreed to pay interest on the loan. Her friend stopped making payments, so the plaintiff filed a small claim. According to the text messages the defendant had been making payments but it was all interest. Can a judge grant a judgment on the amount she is seeking, or can the judge subtract the payments made even though plaintiff states they were interest only?

ANSWER: The judge should determine the total amount that is due at the time of judgment based on the agreement/contract between the parties — and that is the amount that should be in the judgment. When parties enter into a contract, they are free to agree to any rate of prejudgment interest that is not usurious (exorbitant/more than allowed by law). The judge can determine the total amount due by seeing what amount would be due (including principal and interest) if no payments had been made and then subtracting the amount of the payments.

QUESTION: We received a citation without an address. The officer said the defendant was uncooperative and does not have any identification. We tried to find an address with no luck. What are our options for this situation? Can we still send them to collections/issue warrant if we do not have a way to send them any notices?

ANSWER: A warrant cannot be issued, because there is no way to provide the required notice. There is nothing preventing the case from being referred to collections, but there is a concern that the debt would even attach to the right person if the only identifying information that the court has is a name.

This may be a case to flag for the prosecutor to determine if they want to proceed or not. They may also be able to do further investigation to find the person and provide an address/license or identification number.

QUESTION: Plaintiff is filing a small claims petition and is requesting not to put thier address or phone number. Is this information required?

ANSWER: It is required. If they have an attorney, the attorney can use their address and phone number. Please see TRCP 502.2(a)(2). If the plaintiff has been a victim of family violence, sexual assault, human trafficking, stalking, or child abduction, they can apply to the Texas AG's office Address Confidentiality Program. This allows victims of those crimes to use a substitute post office box address publicly, and then there first class mail (including legal documents) are promptly forwarded to their actual address.
